had the opportunity to ask questions, obtain advice as to its meaning and I understand it.

I understand that this document, titled "Au Pair Agreement" may be signed in counterparts and

may be scanned and mailed. A scanned signature shall be considered the same as the original.

In the event of a dispute between the parties concerning the performance, enforcement or

interpretation of this Agreement, such dispute shall be determined by binding arbitration before the

American Arbitration Association or Judicial Arbitration and Mediation Services in Boulder,

California, upon petition of either party. In such proceedings, the parties may utilize the use of

subpoenas as provided in California Code of Civil Procedure Section 1282.6, 1283, 1283.05. The

decision of the arbitrator shall be final and binding and may be enforced in any court of competent

jurisdiction of the Courts of The State of California, because, among other reasons, this Agreement

was negotiated in large part in California, and the EurAuPair Inc. is domiciled in California.

I hereby certify to EurAuPair Inc. that I have adequate financial resources to satisfy all of my

obligations as an Au Pair in the EurAuPair Inc. Program.

I have received a copy of the EurAuPair Inc. Payment Authorization Form and understand the

payment options as set forth in this document.

I understand that whichever method of payment we choose; I am obligated to make payments

according to that method.

I have carefully read this Agreement; I fully understand and agree to all terms and conditions of this

Agreement with EurAuPair Inc. and I have obtained a copy of this document for my records.

No visitors to the House will be allowed with the exception of the Caretaker's guardian, Police, EurAupair representatives or Emergency personnel, and friends of the Caretaker who must be approved in advance by the Host Family.

Adequate Feeding and Accommodation shall be provided by the Host Family.

- On Account of any financial distress on the part of the Au Pair the Host Family has agreed to be open to further Negotiation of the Arrival Fee.
- The Host Family hereby warns all Au pairs not to take this open offer for granted as a means of avoiding their full financial obligation of the Au program.
